4. AIMS

1. To set up and run educational institutes such as schools upto various i.e pre- primary , primary , middle , secondary and senior secondary levels ; colleges including professional colleges i.e . medical , technical , sports , education upto post - graduation level , research institutes and any other type of educational institute which may conduct educational competitive examinations or programmes at Regional , state or national / international level for promotion of education , arts , literature . skills , fine arts & science and technology .
2. To set- up and run charitable institutes / organisations of any type .
3. To do any activity for implementation and promotion of any government (both state government and central government) sponsored schemes.
4. To set up and run using for the purpose of diffusion of useful knowledge or news through print or electronic media for the benefit of general public at large , including publication of books , journals , magazines etc.
5. To set up and run institute / organisation for the welfare of general public at large or for any target group including the purpose of promotion of industry , handcrafts etc.
6. To start the small scale industries for financial growth .
7. To act for social awareness , and developing the honour of the country .
8. To organise camps for raising social awareness , and desire to serve the country of youth , children , women etc.
9. If the society earns any profit or income , then the said amounts will be utilised for the development of sociey .
10. That if due to any reason the society is ordered to be closed , in the said circumstances , no member of the society will be responsible for the same in person .

In circumstances , the society will handed over to some other society having the same ideals etc .

RULES AND REGULATIONS OF SHRI CHANDI RAM EDUCATIONAL SOCIETY
GURGAON

The following conditions are necessary for membership .

1. He should be the age of 21 years .
2. He must have faith in the aims of the society and also obey the rules and regulations of the society .
3. He should not be any type of criminal and moral turpitude .
4. He must pay entrance fee off institution and promise to pay membership charge regularly .
The member will be of three types.

1. **LIFE MEMBERS :-**

A person who donates RS . 11000/- (Rupees One thousand one hundred only) to the society will be life member.

2. **GENERAL MEMBERS:-**

General member will pay Rs 1100/- as the entrance fee and Rs. 500/- for a year.
The membership will be cocealed if :

3. **PRIVILEGED:-**

Only those members who are nominated by majority of the management .

Note :-

- i) He does or becomes insolvent .
- ii) He resigns .
- iii) He is declared as insane .
- iv) He does any act which creates religions social or economical hindrance in the institutes .
- v) He is punished by the court for moral trupitude.
- vi) He does not pay yearly contribution upto three consecutive years .

CONDITIONS:-

The following four conditions are included in the Memorandum of Association of the society .

The income and property of the society shall be applied solely towards the promotion of the objects of the society as set forth in the momorandun of association and no portion there of shall be paid or transferred directly or indirectly to the members of the society .

No member of the governing body of the society shall be appointed any salaries office of the society or any office of the society or any office the society paid fees , that no remuneration shall be given by the society to any member such governing body , except payment out of pocket expenses and interest on money lent or rent for the primises / demises the society .

The society by its consitution required to apply profits it any of the other income in promoting its objects .

If upon the winding up or dissolution of the society there remains of all its debts and liabilities any property whatsoever , the same shall not be paid to or distributed among the members of society but shall be given or transferred to some other institution being objects similar to the objects of the society at or before the time of dissolution .

4. The following additional conditions are included in the constitution of the society .

- a) The income and property of the society shall be applied solely towards the promotion of the objects of the society as set forth in the memorandum of Association and no portion thereof shall be paid or transferred directly or indirectly , to the members of the society .
- b) No member of the governing body of the soiciety shall be appointed to any salaries office of the society or any office of the society paid by fee , that no remuneration shall be given by the society to any mamber of such governing body , except payment of out of pocket expenses and interest on money lent or rent for the premises / demises the society .
- c) The society by its consitution required to apply its profits if any of other income in promoting its objects .
- d) If upon the winding up or dissolution of the society there remains after satisfaction of all its debts and liabilities any property whatsoever , the same shall not be paid to or distributed among the members of the society but shall be given or transferred to some other institution having objects similar to the objects of the society to be determined by the members of the society at or before the time of dissolution .

5. RIGHTS AND DUTIES OF THE MANAGEMANT :

- I. The management will meet at least once in a year for which at least seven days notice is compulsory .
- II. The management will look after the whole affairs of the society .
- III. The emergency meeting of the management will be called at the notice of 24 hours .
- IV. The management will also appoint principal , vice pricipal , Director and other officials staff .
- V. The management will also look after the apportion ment of servants , their salaries retrenchment of the servants , increased or decreased of the salary in the society .

6. MANAGEMENT

The management will look after the movable and unmovable property of the society .

7. GENERAL HOUSE

RIGHTS AN DUTIES

The meeting of the General house will be held once a year of this 3 / 5th members must be present .

- b) The election of the managment will be held once after five years by the general house through secret ballot paper .
- c) The management will be able to anned any low or bye law of the society but it must be passed by majority in the general house .
- d) The total income of the society will be audited , and must be presented in the general house for information and must be passed by majority in the general house.

8. RIGHTS AND DUTIES

1. CHAIRMAN

- i) He will preside over the meeting of the society
- ii) He will look after the proper working in the institution.
- iii) By casting vote with general house is divided in equal groups.
- iv) He is impowered to expands upto Rs.50,000-(Rupees fifty thousand for more amount consent of general house is must).



2. VICE CHAIRMAN

He will look after the affairs of the society in the absence of the chairman and will co-operate with chairman for everywork .

3. SECRETARY

- i) He will call the members of the General house and will do the needful for this .
- ii) To see that rules of the society are executed properly .
- iii) To make correspondance and orders for the proper working of the society .
- iv) To prepare annual report of the society and present it to the general house.
- v) He is empowered to make an expenditure of Rs. 50 , 000/- for more expenses the consent of the General house is must .

4. TREASURER

- i) To keep account of the income and expenditure of the society .
- ii) To make payment of the amount of expenditure passes by Chairman or secretary on obtaining proper receipt .
- iii) To collect subscription .
- iv) To expand Rs 25000/- for the working of the society whenever eassential at a time in a day .

6. Security of Money

The sources of the income of the society will be sub scription grants and fees . The account in the name of the society will be opened in a bank and money will be deposited in that account . The amount from the bank will be with drawn under the signature of any two officials chairman or secretary and Treasurer .

7. RESIGNATION:-

If any member of the managing body of the society of officer esenets his resignation will be presented in the Managing Committee meeting the decision of the managemnet will be final.

8. QUORAM

In the meeting of the management and General House 3/5 member must be present . If the attendance is less than 3/5 the meeting will be called again, in this meeting the fulfillment of the condition Quorum is not complsury .

9. VACANCY :-

If any vacancy is created by the resignation of any official will be fulfilled by the management but it must be passed by majority.

10. ELECTION PROCEDURE:

The election of the members of the management will be held in the General house of ballot voting . The Chairman vote will be vote when two members got equal votes .

11. . AFFAIRS OF THE COURT :

If any suit with institution in the court it will be filed in the name of the society by the chair man only and he will also look after the legal proceeding .

12. AMENDMENT IN RULES ANF BYE LAWS :-

The managemnet is empowered to amend any rules or bye laws but it must be passed by majority in the general house .

13. AMENDMENT IN THE MEMORANDUM :-

If any amendment is made in the memorandum it must be done by the voting in favor of the amendment in the general house U/s 26 the Haryana Registration and regulation as society act , 2012 .
